### ORDER

The Director of General Education, Thiruvananthapuram, vide letter read above forwarded the application of Peace International School, Thathappilly, Mannam.P.O, North Paravoor, Ernakulam with recommendation for recognition and NOC for affiliation to CBSE.

2. While processing the above proposal, Government have received a judgment read as 4<sup>th</sup> paper above in which the Hon.High Court has directed the Secretary to Government, being the second respondent, to take an appropriate decision on the request made by the petitioner for NOC within a period of one month from the date of receipt of a copy of the judgment.
